### DoD/DOE QSM Version 6.0 Transition Reminder

he Department of Defense (DoD) and Department of Energy (DOE) have released an updated version of their Quality Systems Manual (QSM) for laboratories conducting environmental testing. QSM Version 6.0, which replaces Version 5.4, was published on December 13, 2023. Labs must fully transition to the new version by June 13, 2026.

#### What's New in QSM V6.0?

The updated manual has been completely rewritten to enhance clarity and ease of use. Redundant and unclear requirements were removed or simplified. Key changes include:

- Reorganization of content to better support audits and assessments
- Stronger, clearer language (e.g., "shall consider" changed to "shall")
- Consolidation of requirements from appendices into core modules
- New industrial hygiene section in Module 8
- Section 9 now addresses hazardous/radioactive materials and applies only to **DOECAP-accredited labs**
- Clarification that labs conducting radiochemical testing must hold a radiochemical license

#### **Next Steps for Labs:**

Labs are encouraged to review the new version and begin updating internal systems and procedures accordingly. PJLA will continue to support accredited labs through the transition and is available for questions.

Stay ahead of the deadline—prepare now for compliance with QSM Version 6.0 by June 2026. ◆

# Transition To EPA NLLAP LQSR 4.0 Required By December 2025

he U.S. Environmental Protection Agency (EPA) has released updated laboratory standards under the National Lead Laboratory Accreditation Program (NLLAP). The new guidance, titled Laboratory Quality Standards for Recognition (LQSR 4.0), was finalized on October 23, 2024, and replaces the previous LQSR 3.0 (2007).

**Key Transition Requirements:** 

- All NLLAP-recognized laboratories must transition to LQSR 4.0 by December 22, 2025.
- After this date, PJLA will assess LQSR 4.0 regardless of where a lab is in its accreditation cycle.
- The LQSR 4.0 LF-56 working checklist is available on PJLA's website as a resource tool, but labs must refer to the full LQSR 4.0 standard for compliance.

Additionally, labs must now incorporate ASTM E1583-21a into their management systems. This standard addresses testing for lead in paint, dust, airborne particulates, and soil from buildings and structures. A copy must be maintained as an externally controlled document.

PJLA encourages all affected labs to begin reviewing LQSR 4.0 now and conduct internal assessments to plan for necessary updates. Be sure all relevant personnel are informed and involved in the transition process.

### PJLA Proficiency Testing Plan Documentation

JLA has announced critical updates to its proficiency testing (PT) planning process.

#### Effective immediately:

- LF-81 Proficiency Test Plan Rev 1.3 has replaced Rev 1.2. This form must now be used for all PT plan submissions. It no longer includes functionality for alternative PT approvals.
- LF-81a PT Alternative Approval Form has been introduced and is now required for any PT alternative requests. Approval from a PJLA Technical Program Manager is mandatory prior to implementation.

Please Note: Submit this form to PJLA at ptalternativeapproval@pjlabs.com along with the SOP for the approach used (including defined acceptance criteria) for the study type and the LF-81 or equivalent internal form.

Both forms are now available on PJLA's Document Portal and must be used immediately by all CABs and assessors. For questions or support, please contact PJLA headquarters.

# ISO/IEC 17043:2023 Transition Deadline Approaching For Proficiency Testing Providers

he transition from ISO/IEC 17043:2010 to ISO/IEC 17043:2023 is officially underway, with a mandatory deadline of May 31, 2026 for all proficiency testing providers (PTPs) to complete their transition.

#### **Key Dates to Remember:**

- May 31, 2023: New version of the standard published; transition period begins.
- January 1, 2025: All new applications must be to ISO/IEC 17043:2023.
- January 31, 2026: Recommended date to complete transition assessments.
- May 31, 2026: Final deadline—accreditation to the 2010 version will no longer be valid.

PTPs must demonstrate compliance through transition assessments, which may be conducted during routine visits or separately. Failure to transition by the deadline will result in suspension of accreditation.
